- (1) On October 1, 2021, NEIWPCC held ~\$444,758 of FY18 and FY19 EPA Cooperative Agreement funds. On October 1, 2021, RWU was awarded \$1,787,151 via the FY21 EPA Cooperative Agreement, which includes all FY20 and FY21 funds. NEIWPCC is ready to submit paperwork to close-out the FY15 and FY17 grant awards.
- (2) Note that expenditures for NEIWPCC are as of 1/31/22 and RWU are as of 2.1.22.
- (3) Based on current calculations, \$34,707 of NBEP funding remains unallocated at NEIWPCC. The plan is for NEIWPCC to subaward to RWU \$33,507 (all remaining unallocated FY2018 money) to cover staff salary and spend ~\$1,200 (all remaining unallocated FY2019 money) to cover small bills over the next month or so. The only projects we expect NEIWPCC to administer into 3Q FY2022 are the Clark University Blackstone (closes 9/30/22) and Impact by Design DEIJ (closes 4/30/22) subawards.
- (4) Includes Phone, Outside Printing, Internet, Research Supplies, Catering/Meals, Rental Space, Equipment Rental, Event Hosting, Event Meals, NBEP Meeting Meals, Meeting Attendance, Professional Development, Advertising, and Computer Support.
- (5) The RWU budget takes all indirect "off the top" at the beginning of the year, and does not report indirect charged per period or otherwise on an ongoing basis. Therefore, the indirect included in this table is an NBEP calculated figure based on 20% of charged personnel and fringe to date.

Committee Round Robin Updates

Nominating Subcommittee

- NBEP Nominating Subcommittee met on February 2nd
 - Meeting usually takes place each fall, but due to RWU on-boarding, the meeting was delayed
- Dave Janik retired and stepped off the SC last fall
- 7 members are up for reappointment—all organizations would like to continue
- Cassius Spears, Sr with the Narragansett Tribe term expired in 2020

New Members

- Based on the new host, bylaws work, and the size, expertise, and newness of existing membership the subcommittee decided <u>not</u> to recommend new members
- New members will be considered this fall as part of the annual cycle
 - Commercial fishing, tribes, coastal agencies, community organizations will be priorities

Narragansett Tribe

- Cassius Spears, Sr. has been a member of the SC for some time
- He has not been in contact with program for at least 3 years
- Cassius' term expired last year, but we decided to wait a year while we continued to reach out to him and the tribe
- Efforts to engage Cassius and the tribe have been unsuccessful—COVID is added challenge
- Feedback has been that the most respectful approach is to send him a note to thank him for his service, let him know his term has expired, and indicate that we'd like to engage with the tribe when timely for them
- Our DEIJ Assessment will inform actions by the ED and Watershed Outreach Manager to reach the Narragansetts and other tribes

Final Draft NBEP Bylaws

- 10 commenters from SC
- RWU Office of General Council re-reviewed
- 5 changes worth noting based on feedback
- Discuss today with goal to send to SC for final review and approval at their March meeting

1. Standing Committees

- Swapped "Standing Committee(s)" for Management Conference throughout
 - Management Conference comes from Clean Water Act
 - Clean Water Act origin of program is called out in Section 2
 - Folks thought Management Conference language was confusing and dated
 - Standing Committee description moved up Page 1

2. Term Limits

Added narrow exception to term limits

- Desire to cover circumstance where there is simply no other person at a key stakeholder that can take a termed-out member's seat
- Suggested text: "If extenuating circumstances prevent a stakeholder from nominating a new individual to replace an existing member of a Standing Committee who has reached their term limit, limits for that existing member may be waived at the close of a term by a two-thirds (2/3) vote of the Steering Committee."

3. SC Approval of Work Plan & Budget Amendments

- Added clarification that "major" amendments to the annual Work Plan and Budget will require SC approval
 - Want to balance host primacy on personnel issues, flexibility for ED to make decisions, and appropriate SC oversight
 - Major amendments defined as
 - New tasks not in the Work Plan
 - Individual Budget line item revisions that exceed 10% of the year's CWA §320 allocation (for FY2022, \$700,00 was allocated, so individual changes that exceed \$70K would require approval)

4. Executive Committee Composition

- Specified that the EC must include representatives from two nongovernmental organizations, RIDEM, and MassDEP*
 - Perspective was it is vital that the SC include the CWA implementing agencies, and as balance, at least two non-governmental organizations

*The final draft now includes a specific requirement that there be a NGO from RI and MA.

5. Science Advisory Committee Meeting Frequency

- Added back requirement that SAC meet at least 3 times a year
 - A meeting frequency was included in the Guiding Principles, but not in the first draft of these bylaws
