Draft Budget

- 5-15 stormwater project subawards (\$617,000)
- Included meals for SC, Vision 2032, Science Event
- Questions:
 - Fringe and indirect rates are (high) estimates
 - Computer support needs unknown
 - NEED another \$1.1M in match—will request soon
