

# Final NBEP BIL Workplan and Budget

- EPA BIL guidance released July 26<sup>th</sup>
- NBEP's BIL Workplan and Budget provisionally approved consistent with guidance
- No match requirement for Years 1 and 2
- Only change is the award will now include 2 years of BIL funding (changes in yellow in docs)
  - Workplan includes a new objective/task to use an RFP to subaward all Year 2 funding (\$909,857) for projects
  - Budget now is \$1,891,714, covering Year 1 and 2



Since 1987 this place-based program, located in 28 estuaries of national significance along the Atlantic, Gulf, and Pacific coasts, and in Puerto Rico, has developed and implemented long-term Comprehensive Conservation and Management Plans (CCMPs), funding projects that restore the water quality and ecological integrity of their regions. These CCMPs provide a structured framework for the delivery of investments. NEPs involve community members in the decision-making process and the challenges and priorities they address are defined by local, city, state, federal, private, and non-profit stakeholders in coordination with their management conferences. The NEPs<sup>1</sup> collaborative, locally driven approach has over time generated an average of approximately \$22 return on each federal dollar invested, delivering mearly \$6 billion for habitat protection and restoration and water quality enhancement projects.

This NEP BIL Funding Implementation Memorandum (memorandum) applies to funding provided under the BIL and provides guidance on uses of funds, timeframes, how to award the funds, and tracking and reporting requirements. This memorandum describes the process for FY 2022 – FY 2026 BIL funds and may be supplemented by additional implementation memoranda as needed. Unless otherwise noted in this document, the FY 2020 – FY 2024 Clean Water Act §320 National Estuary Program Funding Guidance also applies to BIL funding.

# New Objective 4, Task 4a

barrier to new project development in our study area. For the purposes of this workplan, "projects" are those that reduce pollution, restore habitat, improve climate resilience, and advance environmental equity. "Project development" is the process of advancing projects through the 4-phased, 9-step process from problem to construction described in the graphic below.

#### Task 4a: Support development of projects consistent with our CCMP.

Fund project development in Year 2 that is responsive to Year 1 efforts described in Objectives 1-3 and is otherwise align with BIL priorities, this Workplan, and our CCMP. NBEP will develop a Request for Proposals (RFP), utilize the Grants Subcommittee to review and select projects, and issue subawards to up to 20 entities that serve our study area (individual awards likely from \$50,000 to \$100,000) that advance projects in line with both local priorities and our CCMP. With this task taking place anywhere in the study area, where nearly 80% of census block units include an environmental justice area, it is very likely that some projects developed will take place within and/or directly benefit disadvantaged communities. Task 4a will be accomplished through subawards.

#### FY2021 NBEP Budget vs. Actuals 8.8.22<sup>(1)</sup>

(1) All FY18 and FY19 EPA Cooperative Agreement funds held by NEIWPCC will be fully spent by September 2022 (~\$60K is left to be paid out to close out two subawards funded by FY18 funds). Thus, for the the purposes of this report, these funds are "zeroed-out" and are not included here. We expect NEIWPCC to formally close out these agreements with NEIWPCC by September.

(2) Includes Phone, Outside Printing, Internet, Research Supplies, Catering/Meals, Rental Space, Equipment Rental, Event Hosting, Event Meals, NBEP Meeting Meals, Meeting Attendance, Professional Development, Advertising, and Computer Support.

(3) The RWU budget takes all indirect "off the top" at the beginning of the year, and does not report indirect charged per period or otherwise on an ongoing basis. Therefore, the indirect included in this table is an NBEP calculated figure based on 20% of charged personnel and fringe to date.

(4) On 3.9.22, an amendment to the FY2022 EPA Cooperative Agreement to RWU was approved that realigned the budget to (1) accommodate a higher salary (and accordant new fringe and indirect costs) for the upgraded Watershed Outreach Manager position, (2) add a new line item to cover staff 'Lost Fringe Benefits' in the transition from NEIWPCC to RWU, (3) and shift funds from travel to contracts, and (4) and shift money within existing and to new contracts. Approval documentation available upon request.

(5) This column represents the fact that all but \$1,000 of the \$650,000 budgeted subawards have now under agreement so these monies are not available for the purposes of future projections and budgeting.

(6) We project to have ~\$800K left over at the close of this fiscal year.






# Water Clarity Science Update

- State of Narragansett Bay and Its Watershed included multiple types of data for water clarity
- NBEP formed a Water Clarity Working Group in 2020 to explore how to best communicate and use this data
- Update describes changes in water clarity, reasons for changes, and tools used to measure it, and also hopes to stimulate discussion about how to advance use of clarity in management decisions and identify areas for further research



# Shellfish StoryMap

- Providence River in the Upper Bay opened for quohogging in 2021 for the first time in 75 years
- NBEP is culling data to craft a StoryMap that tracks the actions and resulting water quality improvements from 1995 to 2020 that led to opening
- Desire to show real world results of water quality improvements

# FY2021 Funds Re-Budget

- Expect to have ~\$800,000 of FY2021 dollars unspent on 9.30.22
  - Causes are NEIWPCC's requirement that we keep 1 year of funds in reserve, our roughly 9 months with only 2 staff, and not hiring Vision 2032 contractors while we paused that work
- EPA would like us to reduce this running unspent funds total
- EPA/NBEP staff have discussed
  - Putting out \$400K as subawards to partners this fall habitat/access planning as its next in line
  - Holding \$400K for personnel costs

### **Two Questions**

- 1. Does **50/50 split** of remaining money make sense?
- 2. How to **deliver subawards**—direct award, RFP, both?

# 50/50 Split

- Provides ~9 months of funding for personnel time
- \$400K allows us to support 5-10 substantive planning efforts

# Direct Subaward vs RFP vs Both

- Recent past approach
  - Used RFP for Green Infrastructure Planning subawards with FY2021 320/SNEP money earlier this year
  - Plan to use direct subawards for capacity/planning subawards with FY2022 BIL and 320 funds this fall
- EPA does not require that we compete funds
- NOTE: NBEP has been **soliciting** habitat project planning ideas for several months from SC members and other partners...
